A **Hybrid PAC** — is a political action committee that operates two separate bank accounts, each with different rules:

Super PAC Fund

WHO CAN CONTRIBUTE

- Corporations (unlimited amounts)
- Labor unions (unlimited amounts)
- Individuals (unlimited amounts)
- Other PACs & organizations
- Foreign nationals — prohibited

HOW FUNDS CAN BE SPENT

- Independent expenditures (ads supporting/opposing candidates)
- Electioneering communications
- Issue advocacy & legislative lobbying
- Direct contributions to candidates — prohibited
- Coordinated expenditures with candidates — prohibited

DISCLOSURE

- All contributors publicly disclosed to FEC

Political Giving Fund

WHO CAN CONTRIBUTE

- Individuals — up to \$3,500/candidate/election
- Other PACs — up to \$5,000/year
- Corporations — **strictly prohibited**
- Labor unions — strictly prohibited
- Foreign nationals — prohibited

HOW FUNDS CAN BE SPENT

- Direct contributions to federal candidates
- Coordinated expenditures with campaigns
- Independent expenditures
- Legislative & lobbying activity
- Subject to contribution limits on candidate donations

- All contributors publicly disclosed to FEC
